- Maintain board confidentiality
- Abide by the Planned Pethood Volunteer Agreement
- Participate on a minimum of one committee, or hold an officer position
- Attend a minimum of one adoption event and one fundraiser per election year
- Expect to spend a minimum of five hours of participation per month on board matters

## **Minimum Qualifications**

- Ability to interact with other board members and volunteers, and function as a team
- Ability to communicate and receive documents via email.
